

## Community Project Funding/Congressionally Directed Spending (CPFCDs)

### 1. Project RFA process: Follows regular Federal Aid RFA Process

- Verify application has been approved
- Conditional approval = PE only
- Full approval = ALL Phases

### 2. Before approving project:

- Verify RFA submittal package includes CPFCDs approved application - DISTRICT
- Verify CPFCDs application has all three signatures (local agency MPO/RTPA, headquarters CPFCDs coordinator or manager, and District) - DISTRICT (signature must be there)/OFP
- Verify project is on CPFCDs table - LPA/DISTRICT/HQ
  - Verify applicant/recipient is the same local agency named in table
  - Verify total OA funding amount isn't exceeded in table
  - Eligible project CPFCDs scope of work, must be within legislated description (Check for HQ approval page in application which should be attached to the RFA check application last page approval for comments)

Before approving project:

### Federal Funds for CPFCDs Projects:

- Federal Share: up to 88.53% (See application approval, on last page of application)
- Obligational Authority:
  - Funding is not subject to any obligation limitation that applies to Fed-aid contract authority (OFP keeping track of funds)

Verify in approved application (last page) project approved phase

- Project approved phase
- Reimbursement amount requested for this phase
- Amount of funds awarded to the total project (CPFCDs funds)
- Conditional approval allows for PE only authorization
- Full approval allows for right of way and construction authorization – HQ OFP. District sends RFA to OFP for approval. District then sends RFA to HQ or back to LPA if not approved.

3. Deadlines

- Obligated by Sept. 30, 2025; unobligated amounts after this date shall expire and funds will only be available for adjusting and liquidating obligations per 31 U.S.C. 1553.
- Expended (invoiced) by Sept. 30, 2030; unexpended balances of obligated earmark funds shall be cancelled and are no longer available for obligation or expenditure. Final Invoices for the remaining obligated funds, should be submitted to LPA no later than March 31<sup>st</sup> of the FFY the funding is due.

6. Project creation in LP2000:

- Project Prefix: CPFCDsL - **DISTRICT**
- Select two programs in project creation: DEMO or CPFCDs

- Change in scope, must have reapproval by OFP CPFCDs coordinator
